## **Concept note**

#### 1. Introduction

In the current fast-changing risk and policy context, assessing disaster risk management (DRM) capabilities is crucial to increase resilience and foster comprehensive preparedness. The European Commission's Directorate General for Civil Protection and Humanitarian Aid Operations (DG ECHO), under the Union Civil Protection Mechanism (UCPM) Peer Review Programme, supports the Member States, the Participating States, eligible Third Countries and the European Neighbourhood Policy countries to review their disaster risk management (DRM) policies and practices by taking stock of strengths and weaknesses and putting forward recommendations to increase effectiveness. Peer reviews promote an integrated approach to DRM and support a wider policy dialogue across Europe and beyond, improving policy coherence and facilitating the exchange of good practices.

Developing a robust methodology for assessing Disaster Risk Management (DRM) capabilities is crucial for ensuring the effectiveness, comparability, and consistency of peer reviews. The Peer Review Assessment Framework (PRAF, 2021) and the Wildfire PRAF (2023) have proven effective in supporting comprehensive and holistic analysis during the 2020-2024 Peer Review Programme cycle, and their use now extends beyond peer reviews.

The PRAF is currently being revised and updated to support upcoming peer reviews scheduled for the 2025-2027 cycle. A preliminary draft has already been prepared by the Euro-Mediterranean Center on Climate Change (the contractor assisting DG ECHO with peer review implementation). DG ECHO intends to consult a small group of experts to gather suggestions for further improvement.

#### 2. Purpose and overall objectives of the workshop

The workshop aims to present the draft structure of the disaster risk management framework and gather expert feedback and suggestions. Insights from the workshop will directly support the framework's finalization. Subsequently, the advanced draft of the framework will be shared with the Disaster Prevention Working Group (UCPM) for broader consultation.

#### 3. Structure of the workshop

The full-day workshop is structured in three main parts:

- An introductory session provides an overview of the key ongoing initiatives at European level, focusing on the EU Preparedness Strategy and key UCPM initiatives on disaster risk management.
   The Peer Review Programme and its key reference documents (PRAF and Guidelines) will also be briefly presented, along with the draft structure of the new disaster risk management framework.
- A World Cafè session structured into three breakout sessions (one in the morning and two in the afternoon) represent the core part of the workshop. The experts are divided into 3 groups to analyse and discuss the draft structure of the PRAF, addressing specific key focus areas¹ in each break-out session. A facilitator guides the discussion in each group with the support of guiding questions. Each group moves from table to table, providing feedback on every key focus area within the framework.
- A **closing session** focuses on the insights gathered during the break-out discussions. One (or more) facilitator(s) from each group presents the key results. A brief open discussion follows the presentation and a timeline for the next steps is agreed upon.

Coffee breaks and a light lunch are organised by the European Commission at the meeting venue.
